6. **WHEREAS,,** it is the statutory duty of the Zane Trace Local School District Board of Education to deliver the quality education programs and services to the school children of the Zane Trace Local School District, and

WHEREAS, members of the Board are elected by the Zane Trace School Community to ensure an effective, efficient, and productive education to its students, and

WHEREAS, the charter school industry with assistance of the Ohio Department of Education and others, has taken the sum of \$1,499,672 from the Zane Trace Local District, its students, and its taxpayers since 2009, and

WHEREAS, the charter school industry extracts in the range of \$1 Billion dollars annually from public school districts across the State of Ohio, and

WHEREAS, school district boards of education have no control of students, financing, educational programming and student outcomes who enroll in charter schools, and

WHEREAS, Charter Schools in Ohio have demonstrated an overall low academic performance compared to public schools, and

WHEREAS, THE Charter School Industry has created a climate of waste, fraud, abuse, and corruption that is threatening to permeate all branches of government, including the Ohio Department of Education, undermining confidence and trust in our public institution, and

WHEREAS, the State of Ohio has demonstrated its lack of capacity to effectively monitor and police the Charter School Industry, resulting in the U.S. Department of Education's recent withholding of a \$71 Million grant to Ohio, and

WHEREAS, THE Charter School Industry's confiscation of \$1,499,672 from Zane Trace taxpayers and students has reduced educational programs and opportunities to Zane Trace Local students;

Now therefore be it RESOLVED that the Zane Trace School Board of Education calls on the Ohio Legislation to pass legislation that eliminates the State policy of extracting Charter School Tuition and Funding from the local public school districts and their taxpayers, and

Be it further RESOLVED that the Zane Trace Board of Education directs the District Treasurer to invoice the Ohio Department of Education for all funds extracted from Zane Trace Local District for Charter Schools.
